Article 1, Section 27 of the Pennsylvania State Constitution, also referred to as the Environmental Rights Amendment, which was passed by referendum in 1971, states that......

The people have a right to clean air, pure water, and to the preservation of the natural, scenic, historic and esthetic values of the environment. Pennsylvania's public natural resources are the common property of all the people, including generations yet to come. As trustee of these resources, the Commonwealth shall conserve and maintain them for the benefit of all the people.

The recent Pennsylvania Supreme Court decision regarding Article 1, Section 27 suggests that the second sentence of the Amendment establishes that the people own the public natural resources not the Commonwealth and the third sentence of the amendment establishes a public trust. It is believed that this would suggest that the trustee (Commonwealth) must act affirmatively to pass such laws as will best preserve the subject of the trust, and secure its beneficial use in the future for the people of the state. This would further suggest that proceeds from the lease of state land and the sale of natural gas and oil are part of the corpus of the trust and must remain part of the trust.
